

**ORDINANCE NO. 1448**

**AN ORDINANCE AUTHORIZING THE CITY OF MANCHESTER, TENNESSEE TO ENTER INTO A CONTRACT WITH ROGERS GROUP, INC. FOR PROVISION OF CERTAIN ROAD MATERIALS**

WHEREAS the City of Manchester, Tennessee annually constructs and maintains City streets as the need arises; and

WHEREAS the City of Manchester, Tennessee solicited proposals for certain materials to be provided and work to be performed to that end during fiscal year 2015 – 2016, which solicitation is attached as Exhibit “A” and incorporated by reference; and

WHEREAS the sole proposal for said work and materials was that submitted by Rogers Group, Inc. which is attached as Exhibit “B”; and

WHEREAS Manchester Municipal Code 5-703 provides:

**“It is the policy of the board of mayor and aldermen for a minimum of two bids however, if only one bid is obtained, the initiating department shall consult with the finance director and may exercise the option to extend the bid period up to 30 days, without opening the submitted bid, to allow for additional bids. If the determination is made to open the sole original bid, or if no additional bids are received during the bid extension, the committee, commission or board may:**

- (a) Re-advertise;**
- (b) Order the work done by city employees;**
- (c) Award the contract to the sole bidder based on a cost analysis evidencing the relationship of the one bid to expected market price;**
- (d) Negotiate a contract to the best advantage of the City.”**

and;

WHEREAS the Board of Mayor and Aldermen believes it best to award the contract to the sole bidder based upon a cost analysis evidencing the relationship of the one bid to expected market price; and

WHEREAS Manchester Municipal Code Section 5-703 (4) of the City of Manchester requires any obligation of the City on any contract in excess of \$25,000 be approved by ordinance; and

WHEREAS, based upon the analysis described above, the City of Manchester, Tennessee desires to accept the proposal of Rogers Group, Inc., which is attached hereto as Exhibit “B” for the work and materials described therein.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF MAYOR AND ALDERMAN OF THE CITY OF MANCHESTER, TENNESSEE that the City of Manchester accepts the proposal of Rogers Group, Inc. (attached as Exhibit “B”) to perform the work described in Exhibit “A.”

BE IT FURTHER ORDAINED that the Mayor and Finance Director are authorized to execute the contract documents on behalf of the City of Manchester.

BE IT FURTHER ORDAINED by the Board of Mayor and Aldermen of the City of Manchester, Tennessee that this Ordinance shall take effect on and after its publication and passage, the public welfare of the City of Manchester, Tennessee requiring it.
